

Administrative Order 10-3 dramatically increases the number and type of documents that may be filed through eDCA.

E-FILING PROCEDURE

This will result in the addition of several “Document Type” categories on the e-filing page of eDCA (as shown.) These “type” categories will work just as the existing briefs and petitions types work now. Once a “Document Type” is selected any of the specific documents within that type will populate the “Document” pull-down menu field. To file a document, simply select a document type, then choose the specific document to file. Fill out the remaining fields appropriately and attach the appropriate PDF document. When satisfied with your filing choose “Upload.”
